In particular, the **Plan for cross-communication, knowledge transfer and activity integration** is now available, and its implementation already ongoing.

Workshop on Future Priorities

On 21 May 2015, a number of Work Package leaders met in Brussels, Belgium, to discuss how to best advance the project in the next 6 months.

The focus of the meeting was on the following most immediate priorities:

- Roadmap initiation: Bottom-up identification of Hubs of Coordination (HoC) on very rare tumours that will support respective study groups and function as tumour boards for national and/or cross-border advice.



Here, participants worked on the first possible prototypes of Paediatric Oncology European Reference Networks (PO-ERNs) in the fields of Very Rare Cancers and Retinoblastoma.

- Evaluation questionnaire: exercise to identify centres in Eastern European countries that

fulfil the requirements of the European Standards of Care for Children with Cancer and may become twinning partners interacting with HoC in shared cross-border health care models.

Template questionnaires were analysed by the workshop participants to produce a final draft of targeted questions. The expected outcome of the questionnaire is a list of centres that can effectively interact with a PO-ERN. Results will also support decisions on whether treatment can be done in the home country or requires cross-border transfer of the patient. The European Standards of Care for Children with Cancer underpin the initiative.

- IT solutions for tumour boards: the features and costs of IT e-health tools for a tumour boards' forum, case consultation and exchange of clinical data were discussed.

Participants agreed that a comprehensive comparison among the available IT tools is needed to effectively balance the criteria of interoperability, flexibility and cost for a possible choice within the project.

- Paediatric Tumour Board Questionnaire: WP5 (Paediatric Oncology tumour board ERN based on e-Health/ICT concepts for sharing and providing expert advice) outlined two questionnaires targeting respectively Paediatric Oncology Units & European Paediatric Oncology Groups.

The best way to reach all European Paediatric Oncology Units with this questionnaire will be by getting into contact with:

- the Chairs of the NaPHOS (National Paediatric Haemato-Oncology Societies)
- the Chairs of the ECTG (European Clinical Trial Groups)
- Very Rare Tumours (VRT) webpage: the details of the future webpage dedicated to inform families and the public on VRT has been discussed.

It will be built in collaboration with SIOPE and integrated in the ExPO-r-Net website with links to the SIOPE and ENCCA websites.

A Doodle has been sent to hold the next workshop with WP leaders over the summer.
